REGISTRATION:

PLEASE TAKE NOTICE that any qualified elector of Orangeville Township who is not already registered, may register to vote at the office of the Orangeville Township Clerk, the Office of the County Clerk, a Secretary of State branch office or other designated state agency; or can use the Online Voter Registration System at www.Michigan.gov/vote.

Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is MONDAY, July 22, 2024. (MCL 168.497)

After July 22, 2024, anyone who qualifies as an elector may register to vote in person with proof of residency up to and including through the day of election (MCL 168.492) at the Orangeville Clerk's office at the following times:

County Proposal:

Millage Renewal Proposition for Funding the Operation of Older Citizens Services Through Barry County Commission on Aging

Shall Barry County renew the previously authorized millage of 0.4665 mill per year, (\$0.4665 per \$1,000 of taxable value) upon all taxable real and personal property in the County and shall said millage be increased by 0.0335 mill (\$0.0335 per \$1,000 of taxable value) to restore amounts reduced by the Headlee Amendment since the millage was first authorized in 2004, resulting in the levy of 0.5000 mill (\$0.50 per \$1,000 of taxable value), for a period of (5) years, 2025 through 2029, both inclusive, subject to reduction as provided by law?

Township Proposal:

PROPOSAL TO RENEW MILLAGE FOR ROAD IMPROVEMENTS

Shall the previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Orangeville Township be renewed at 1.5 mills (\$1.50 per \$1,000 of taxable value) for the period of 2025 through 2028 inclusive for township road improvements; and shall the Township levy such renewal in millage for said purpose, thereby, raising in the first year an estimated \$291,119.94.
